By signing this document I warrant I understand that:

1. The Terms (as displayed and available in printed form) includes important exclusions and limitations of liability and indemnities that I have agreed apply to me and operate to the benefit of BridgeClimb, the RMS and any reseller of BridgeClimb product. I understand I may now request a copy of the Terms if I wish to again read them.

2. I have entered and remain on the premises of BridgeClimb and the RMS, and I will participate in the climb, at my own risk.
3. I agree to indemnify BridgeClimb, the RMS and any reseller of BridgeClimb product against any loss, damage or claim suffered or brought against any of them, arising out of or in any way in connection with my participation in the climb, or a breach by me of the terms of this document or the Terms (to the extent permitted by law).
4. BridgeClimb and its authorised sub-contractors have the authority to use and reproduce any photograph taken of me for any purpose including display and sale by or on behalf of BridgeClimb without any compensation to me.
5. Photographs acquired from BridgeClimb remain copyright to BridgeClimb. They must not be reproduced or used by me or anyone I authorise for any commercial purpose, including promotion of any supplier or any supplier's products or services, without BridgeClimb's prior written permission.
6. BridgeClimb will rely on this declaration and is not responsible for my decision to climb.
